Doctor Jacobs and Mr. Hybrid: Take us to your hybrids, Dave

Did you notice how David Jacobs, in his interview with [George Knapp](#) this past weekend, consistently acknowledged that there were rules governing hypnosis but they didn't apply to him?

In fact, he created a new category of hypnosis: alien-abduction hypnosis, a practice he, of course, is expert in.

Let's remember please that there are essentially two practitioners in the world of the kind of hypnosis David Jacobs is talking about and neither of them are subject to supervision of any kind, nor are they members of any kind of board of review where ethical guidelines are upheld.

Essentially, they get to make up the rules as they go along.

Well, this is something David Jacobs is pretty good at. He's very good at stating the flaws in hypnosis, in memory retrieval, and in the alien-abduction phenomenon itself but those flaws never seem to apply to him.

That's because David Jacobs is a sociopath. Sociopaths believe that rules apply to others and not themselves. He is very good at avoiding responsibility for his actions, another trait of the sociopath. His infantile argument, infantility being another aspect of Sociopaths, that the audio Emma Woods has released was edited, implying that it was doctored, can pass for authoritative in paranormal churches, such as Coast to Coast AM, where thinking is not allowed and Jacobs is often a visiting pastor. But the audio tracts released are clearly recordings of David Jacobs. They clearly hang him by the neck until dead in nearly every subject they cover. They omit confidential information, such as Emma Woods's name, and the names of Elizabeth Smith and Brian Reed.

Only a sociopath, who is a fully functional moral moron, would contend that the protection of confidential information was unethical.

David Jacobs asserted that the release forms he had Emma Woods sign constrain her from sharing the recordings and Knapp pointed out that they entitle Jacobs to publish his findings.

The validity of the release forms can be attacked on several legal grounds, not the least of which, as Emma Woods will point out in a soon to be published piece, the ground of fraud. Jacobs had Miss Woods sign a Temple University Release Form. It implied he was operating under the imprimatur of Temple University and the University has denied this.

Additional evidence of Mr. Jacobs's sociopathy lay in his snickering dismissal of Emma Woods's attempt at redress with the U.S. Department of Health and Human Services. Mr. Jacobs, for the duration of his career, has enjoyed a state of lawlessness when it comes to oversight of his work in general and the absolute negligence of U.S. Law with regard to the practice of hypnosis in particular. A sociopath snickers at the law because he feels joy in lawlessness.

Miss Woods sought redress through the only body of law addressing anything like the abominations wrought by alien-abductionist hypnotists. That law is the [Code of Federal Regulations, TITLE 45, PUBLIC WELFARE, Department of Health and Human Services, PART 46, PROTECTION OF HUMAN SUBJECTS](#).

This law, as applied to the Emma Woods Case, could also invalidate the release forms Jacobs claims permit him the liberty to do whatever he wants.

Section 46.116 of the Code of Federal Regulations says in part in the first paragraph

that “[n]o informed consent, whether oral or written, may include any *exculpatory language* through which the subject or the representative is made to waive or appear to waive any of the subject’s legal rights, or releases or appears to release the investigator, the sponsor, the institution or its agents from liability for negligence.”

The emphasis was supplied.

The “Research Agreement” signed by David Jacobs and Emma Woods, in the second paragraph, contains the following exculpatory language:

“I understand that David M. Jacobs is neither a professional hypnotist nor a psychologist, nor a therapist. David M. Jacobs has informed me that *serious psychological problems could arise as a result of memory collection. I assume full responsibility for all the memories that I recover.* I understand that all memories might not be reflective of reality. *I assume full responsibility for and I release and absolve David M. Jacobs from all liability for any physical or psychological problems that I might have during and after the memory recovery process.*”

The emphasis was supplied.

The phrase “I assume full responsibility” is an exculpatory clause, not a disclaimer.

The phrase “psychological problems” voids the consent form on vagueness grounds. No mention is made that in all likelihood memories of severe psychological and sexual trauma and physical torture could ensue or that the client may be asked to wear a chastity belt or a modern version of a tin-foil hat or that she might be asked to assist the researcher’s flight from aliens. The consent obtained was informationally insufficient and would not constitute informed consent.

The assertion that memory retrieval is occurring is arguably fraudulent. And recognized experts in every corner of the globe could be found contesting hypnotic memory retrieval.

In every corner of the globe except the Paranormal Church of Alien Abduction Triumphant.

In addition, the sociopath in the instant case had Miss Woods sign multiple release forms. In addition to the Research Agreement Form, he had her sign a Temple University Release Form.

You’ll notice that Paragraph 3 stipulates that Emma Woods’s remarks are on the record and enter the Public Domain. The release of audio containing her “remarks” is arguably in the Public Domain. In addition Paragraph 3 conflicts with Mr. Jacobs’s attempt to become sole proprietor of the material in the Research Agreement cited above. Conflicting provisions render the overall consent incoherent and therefore void.

You’ll also notice that Paragraph 5 conceivably establishes a fraud case against Mr. Jacobs.

Because Emma Woods is attempting to establish the rule of law in an area of lawlessness, a sociopath, quite logically, would take exception to her ethics.

Bear in mind that Mr. Jacobs had been contemplating writing a book on standards in alien-abduction research.

I’ve contended elsewhere that Mr. Jacobs psychologically, for all intents and purposes, is a hybrid. I based that on similarities between his behavior and the behavior of the hybrids as created by him in the Emma Woods Hypnosis. One of the features of hybrids Jacobs claims is their sociopathy.

They do whatever the hell they want to do. Well, Jacobs does whatever the hell he wants. Hybrids have no sense of morality. Mr. Jacobs, consistent with his repeated refusal to concede that rules which apply to others apply to him, has no sense of morality.

His use of the MPD diagnosis in the Emma Woods Case is a prime example. In the faith-based interview conducted by Mr. Knapp, he makes light of the crime and defends his actions by stating that posthypnotic suggestions almost never work in the alien abduction scenario.

That begs the question as to why he would deploy it in the first place if it didn't work.

But let's leave that aside.

The assumption he's operating under appears to be that hypnotic subjects cannot do anything they don't want to do. In other words, they won't comply with leading information if it will hurt them.

Here are two words for you: Judith Peterson. (See [MPD in the Courts](#), search argument: Peterson, False Memory Syndrome Foundation.)

Miss Peterson was charged with creating MPD using hypnosis in patients in a Texas mental hospital and treated them for the condition using psychotropic medication. The central motif was Satan Ritual Abuse and the scheme, it was charged, was an ingenious marketing plan deployed in the bible belt, ostensibly to increase insurance revenue. She settled out of court.

I'll remind the reader here that Mr. Jacobs, in his MPD suggestion, stated that he thought Miss Woods should take medication.

Obviously, the notion of Satanic Ritual Abuse isn't any pleasanter than Alien Abduction and the patients there were not constrained by the idea that, in their hypnosis, they would not do anything that would hurt them.

So, the assertion that hypnosis does no harm or can do no harm is ludicrous.

The Peterson case parallels Jacobs in almost every respect: The use of the MPD diagnosis in hypnosis, psychologically abusive paranormal scenarios, and targeting populations vulnerable to manipulation.

Jacobs is almost certainly aware of that case. The website that documents Peterson's activities is the False Memory Syndrome Foundation. They are stationed in Philadelphia. Jacobs has cited them in his books.

He just doesn't think their work applies to him.

Take Us to Your Hybrids, Dave

Everything I've just written and everything I've ever written explaining the Emma Woods Case and everything any other critic has written regarding the case is **COMPLETELY IGNORED** by Preacher Jacobs and his Church of Alien Abduction.

And I think Jacobs's consistent public humiliation of Emma as a "deeply troubled" person is deeply bigoted. His infantile rage is a public disgrace. If there is anyone who is deeply troubled here, it is the paranoid-schizoid Jacobs.

So let's get down to brass tacks, shall we?

In the interview, Mr. Jacobs stated, in the first hour, that he is under threat from Elizabeth Smith's hybrids. He was convinced of this by the hybrids' use of instant messaging to threaten him. In fact, in a tract from the Emma Woods Hypnosis, Jacobs, confident he could distinguish a hybrid from a human (he insists in his mythology that the new wave hybrids are indistinguishable from humans), boasted to Woods that he could blow the Hybrid pestering him and Miss Smith away with a [shotgun](#) (mp3 file) and that the supervisory Gray Aliens didn't like that.

"While I was hypnotized during my eleventh hypnosis session," Woods stated in Part One of her complaint to the oversight committee of the Office of Human Research Protections, "Dr. Jacobs told me that 'aliens' were ultra-protective of 'hybrids' who were assimilating into human society."

"[T]hey [ostensibly the supervisory aliens] are pressuring her [Elizabeth] extremely to keep quiet, because they know she's talking to me. ... And the pressure has been intense. Really ... extremely intense. I mean, they are so protective of him [the hybrid in question], it is ... beyond imagination," he told Woods.

Well, here's an opportunity to bring that about.

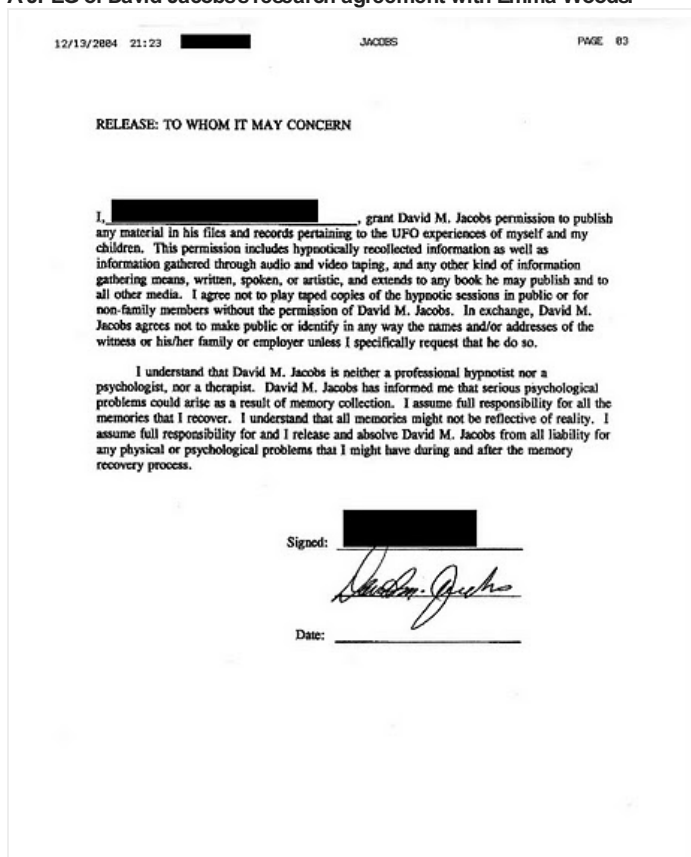

"(370.9) Although I knew consciously that N. was a human being, after my nineteenth hypnosis session I nevertheless found myself checking to see whether he behaved like a human or a 'hybrid'.

"(370.10) I discussed it with Dr. Jacobs by email [the original typos are labeled 'sic']:

"(370.10.1) Myself: I was thinking today about that guy we were talking about who lives in my apartment building. His name is [N.'s name] and he is the only single guy in the building. I am not good at remembering time frames, but he has lived here for well over a year, probably longer, and I have never seen him using the flats communal laundry and I have never seen him taking laundry out or bringing it back. (There are no laundry facilities in his apartment.) I have also never seen him putting out [garbage]. I think I might

have seen him going up to his apartment once carrying a plastic bag of something, but apart from that I have never seen him bringing home bags of food and groceries from the supermarket. I have never seen anyone visit him, and I have never seen him arriving or leaving with anyone. I have only ever seen him by himself. I know it is 99.9999999% not relevant, but I thought I would tell you after the hypnosis session.

...

“(370.10.3) ‘Myself: I feel a bit scared after thinking about [N.], even though I know it’s almost certainly nothing. I hate the way the phenomenon makes you have to think along these way out lines. I feel disconcerted that [N.] doesn’t do all the normal things, even though I know he is almost certainly just a human person.’

“(370.10.4) ‘Dr. Jacobs: The chances are that [N.] is just a normal or seminormal [sic] guy with a suit. He seems to have a job and he goes about his business just like everyone else. However, all you [sic] suspicions could be right. We’ll probably never know unless you see him in ‘unusual circumstances’ one day.
