## The Hyperbolic Chamber: Bozotopia, Or Don't Blame the Clowns for What the Circus Did to Them

*Doctor David Jacobs: Retire.*

A while ago, there was a post to this blog attesting to the fact that Gene Steinberg had "manned up" in the Emma Woods Case and had admitted that hypnosis was not a proper vehicle for investigating alien abduction. I did not dress him down on that post for his ridiculous assessment of Emma Woods's mental health or his equally idiotic suggestion she doctored the audio files she has released.

To the scholars out there who read this blog, I ask you to forgive me for we're about to enter the Hyperbolic Chamber.

It was a half-assed analysis, by me, of a half-assed analyst.

For readers not familiar with Steinberg, he's the host of the Paracast, a podcast turned radio broadcast that is popular in the paranormal "community." The word community is used advisedly because it is clear the "community's" members despise one another. They're constantly at each other's throats and deep suspicion basically ruins their capacity to think. That's why they often get humiliated in debates with Skeptics. The religious fervor of the paranormal community, appealed to by Steinberg and which functions as the economic base of his show, has a compromised ethical structure, so much so that psychological torture is permissible where catching a crook is not.

What Steinberg says about the Emma Woods Case is important because he has consistently repeated, like a mantra, as though in trance himself, the basic defense David Jacobs makes of his behavior in the incident. He, Steinberg, is once again contending, in response to [Jeremy Vaeni's article](#) on the case in UFO Magazine, that the audio files Emma Woods has released, containing excerpts from an estimated 6 days worth of archived material, were doctored and that she is mentally ill. That is David Jacobs's contention point for point.

Steinberg does for mental illness assessment what the Hindenburg did for dirigibles. His helium filled analysis has blown laughing gaskets in his brain. *David Jacobs* is mentally ill. David Jacobs couldn't tell who the client was in the hypnosis while the ethically challenged Steinberg can't tell who is emotionally troubled in analyzing that hypnosis.

For his part, Jacobs should publicly retire from investigating alien abduction and never lay his paws upon a hypnotic subject again. He suffers horribly from an identification problem that stems exclusively from his work in hypnosis and he will only rub himself out if he continues. He is psychologically identified with the sadistic perpetrators he created in the Woods hypnosis and elsewhere and he is in need of assistance. Gene Steinberg is not the assistance he needs.

slaughters them when they take the crap seriously.

Make no mistake, I participated in that seduction. I downloaded the podcasts. I listened to the silliness. I was completely blind to the wanton destruction this community levels upon the lives of its members. But I don't want to be entertained anymore. I don't want to be sold a creepy bill of goods while the seller trashes lives. The novelty has worn off.

I like horror. I like science fiction. I don't like my literary and cinematic tastes being manipulated by Steinberg's Bozotopia and its ring masters.

Look, David Jacobs takes the existence of his Goblins seriously. Were that not the case he'd be easily accounted a fraud and their existence could be questioned *a priori*. Glaringly, though, he never packed up and left town or took any measures to protect his family at the time he sadistically implanted the MPD diagnosis suggestion in Emma Woods's mind, a maneuver he deployed ostensibly because his life was at risk. Whether Jacobs is a sadist or a sadistic fool, the fact remains he is adamant about the *Threat* the Goblins pose.

Indeed, Jacobs's life seems to be remarkably free of the suffering his clients undergo. How is it that the Goblins have free reign over the lives of Jacobs's clients while he writes bestselling accounts of the suffering the clients endure, comfortably traveling the globe, lecturing the ignorati about a looming threat to which only he is immune? Surely, psychic Goblins from Zeta Reticuli would have no problem locating the good doctor and administering the same punishment to him.

There is a measurable difference in the risk to Jacobs's life on the one hand and the risk to his narrative on the other. Where his narrative is threatened, his clients suffer. There is no parallel evidence of similar suffering on his part.

Let me reiterate: The *Threat* is proof of the Goblins' existence. In an exchange with Emma Woods I outlined in the *MPD of David Jacobs*, he tries to reassure Emma, in a moment of narrative weakness on his part, that the Hybrid threats to his life and hers were empty. In an existential epiphany, he suddenly realizes he has placed the coherence of his entire project in jeopardy and swiftly reasserts that the Goblins sexually and physically assault her. He does this because he knows that the basis of his proof of the existence of his sexually and physically sadistic alien human hybrids depends upon the *threat* his clients feel the Goblins pose to *their* existence. This is why he later blends abductee testimony together and asks his clients to meet. It is why they eventually appear together in orgies in the hypnoses. A contagion is created through the involvement of real people in simulated traumas. The fear contributes to compliance. The threat is corroborated by Jacobs's social networking of his clients.

The *threat must* be corroborated to be real. Events in the real world *must* verify the *threat*.

If the *threat* is not real, the Goblins aren't real. Suspiciously, the threat appears to be exclusively directed toward the client and not Jacobs. But if Jacobs's Goblins are real and possess the awesome power he asserts, shouldn't David Jacobs be dead by now?

To state it differently, given that the reality of Jacobs's Goblins is in serious question, how might David Jacobs reverse the momentum and use reality to verify his findings?

*The Suicide Clause: The Sick Analytic of Paranormal Conspiracy Theology*

Dr. Jacobs, the paranormal community destroyed *three decades* of your life. You can get back what remains or you can let this crap kill you. Nothing in the paranormal "community" is worth it. *Nothing*. Retire. Face up to what you've done, see this crap for what it is, pay the debt you owe society, to Emma Woods and to the others you've damaged, and move on. Go back to the history books. Even if it's at the prison library. See if you can salvage a life. The adoration of fools is not worth your self-respect. That adoration is what got you here in the first place and it is what will drive you to your grave if you're not careful.

If you have been compromised by a badly misshapen mutual hypnosis, in the Emma Woods hypnosis or any of the others, you are in a precarious position if your mind is trying to manifest the fictional world you created. From the text of the Emma Woods hypnosis, you'll remember, you end up dead. One of the themes arising out of that hypnosis is that the Hybrids murder you or make you commit suicide. I don't need to remind you of the many instances where people have been so caught up in the paranormal world that they took their own lives. That is what the paranormal world does to people. It is Bozotopia. It is a circus that kills its clowns.

*That's part of the show. That's the main event. They want their pound of flesh. They want to be able to say you were suicided by hybrids. Don't be so obsessed with*

verifying the reality of aliens on earth that you provide your own corpse as evidence. I know you know what your audience wants. Let's end the play here.

Judging from the literature on hypnosis, it is entirely possible you'd attempt to comply with your own hypnosis in an effort to salvage your career as an alien abduction researcher. I am troubled by your misquotes. That's why I continue to close threads on this subject in our forums because, frankly, several posters simply cannot read. They continue to misrepresent, as you've done, my position, which is stated here, once again for the benefit of those who can read;

1. I do not necessarily agree with the approach Dr. David Jacobs takes to UFO abductions. For one thing, the use of hypnotic regression to unearth lost memories is very controversial. We featured Kevin D. Randle on The Paracast, who doesn't accept the practice as useful.

2. I think Jacobs got in over his head in getting involved in the "Emma Woods" situation. Whether he actually abused her in his "treatment" is definitely something that should be investigated, though the authorities who have responded to her complaints so far have given Jacobs a clean bill of health.

3. My dealings with "Woods" have demonstrated that she is a smart woman, Web savvy, and perfectly capable of taking recordings out of context or even applying misleading edits to them, whether deliberately or not, I don't pretend to know. She does admit to editing them, though she claims it was to remove personal information that might reveal her true identity.

4. I also feel that her behavior does mirror the claim of Dr. Jacobs that she is "obsessive," and I'm also concerned by her inability to discern simple distinctions, such as he claim that minor changes to Jacobs' online posting about the matter were changed substantially. At best, she could produce only a few words or phrases that were updated.

5. I'm also troubled by the fact that Jacobs' lengthy online response has been largely ignored by most of the "Woods" supporters. Let's treat this matter fairly, for once.

My final comment on the matter is that it would make sense to have Dr. Jacobs and his investigative techniques evaluated by the UFO community, but "Emma Woods" is clearly a troubled person, and she may not be the best example of the smoking gun.
